1. Purpose of Paper

- 1.1 The purpose of this report is to inform the Audit and Risk Assurance Committee of significant developments within the Executive since the last Audit Committee in September 2013.

2. Annual Accounts

- 2.1 The BTP six-monthly Consolidation Pack was submitted to DfT on the 8 November and was approved by the Authority Finance Director.
- 2.2 We are still waiting to receive the revised Management Assurance Return (MAR) for the nine months to December 2013. At present we have not received any indication as to when we can expect the revised template for submission.

3. PSAs

- 3.1 Since the last meeting there is still one core PSA holder who has not signed the core 2013 PSA. Payments are being received by BACs and we are liaising with DfT concerning this on-going issue.
- 3.2 Devon and Cornwall Railways Ltd, who are a small freight operating company, have recently signed a PSA. They will be invoiced their full charge for 2013/14 shortly.
- 3.3 The TfL PSA agreement is yet to be signed. Work is continuing with TfL, Weightmans, DfT and the Authority. Progress has been made on the insurance issue.

4. Budget 2013/14

- 4.1 The DAC approval process continues. The Authority are still experiencing delays between submission and receiving approvals.

- 4.2 The MTFP was presented and discussed at the Finance Committee on the 22 November along with the proposed Authority budget for 2014/15. Both of these will be presented to the December Authority meeting for approval prior to the detailed 2014/15 budget being scrutinised by the January 2014 Finance Committee.

5. Pension Issues

- 5.1 The proposed new pension strategy for the police officer scheme is due to be presented to the December Authority meeting for discussion and agreement.

6. Internal Audit

- 6.1 Two internal audits have taken place since the last Audit and Risk Assurance Committee meeting. These are presented at agenda item 9. Since the last meeting the new Senior Auditor has started, and an additional resource from DfT has submitted vetting forms to ensure resilience within the internal audit team.
- 6.2 BTP have requested, and it has been agreed, for DfT to carry out an additional internal audit on the Information Assurance Maturity Model (IAMM). DfT have accommodated this within the 2013/14 plan.
- 6.3 Work has commenced in preparation for the 2014/15 internal audit plan with a meeting arrange between DfT and the Authority on the 6 December.

7. Gifts and Hospitality Register

- 7.1 In line with good governance in public bodies, a copy of the gifts and hospitality which have been received, accepted or declined by Authority Members and Authority Executive staff has been prepared for oversight. Appendix A lists the full details for the Authority.
- 7.2 The Chief Executive has also reviewed the BTP Gifts and Hospitality Register with the Deputy Chief Constable which is attached at Appendix B.
- 7.3 Members are asked to note the Gifts and Hospitality Registers.
