Performance since 2005/6

Crime down year on year for 7 years

- Notifiable crime down 24%
- Notifiable detection rate up from 21% to 32%
- Robbery down 69%
- Staff assaults down 15%
- TPP down 30%
- 93% emergency calls answered within 10 seconds
- 91% immediate incidents reached within 20 minutes



Performance 2010-11

- 3% reduction in overall crime
- 4% reduction in serious violent, sexual and robbery offences
- 40% increase in detections football related offences
- 32% notifiable detection rate
- 27% increase detections ASB between 8pm and 2am
- 91% immediate response to incidents in 20 minutes



Financial context

- 2010/11 budget 2.5% real term reduction on 2009/10
- 10% reduction discretionary spend delivered
- Strengthened reserves £4.8m to support reduced PSA charges
- Identified savings of £8.2m for 2011/12, delivering a 3.3% budget reduction and 2.5% reduction in PSA.



Organisational efficiency

- Improved financial grip and control
- Change in vehicle maintenance provider £100k savings achieved
- 532 operational days gained due to reduced sickness last year
 - 62% employees no sick leave in 2010/11
- Voluntary Severance Scheme 20% reduction in Chief Inspector rank and above
- Wide Area Network £1m annual savings off existing contract



Operational efficiency

- Single patrol
- Late night / weekend deployment
- 24hr Inspector cover
- Improved rostering
- Hub policing
- Redeployment of resources to priorities
 - Cable Theft
 - Disruption
- Event planning deployments reduced



Stakeholder engagement

- Extensive engagement with the rail industry, Network Rail, Transport for London, Central Government, Scottish Parliament, Welsh Assembly, ACPO(S), ATOC, Passenger Focus
- Engagement through development of Strategic and Policing Plans
- Enhanced media profile
