## **1.** Purpose of paper

1.1 To propose a work plan for the Performance Review Group for 2010/11.

# 2. Work plan 2010/11

2.1 As discussed at our last meeting discussions with HMIC, NPIA and other authorities have directed the Police Authority to focus its reviews of performance on those areas of highest risk. As previously indicated this could include risks in terms of;

Levels of investment Organisational reputation Legal compliance

- 2.2 At our meeting on the 22<sup>nd</sup> June Members expressed an interest in developing a both a suite of regular performance indicators and a programme of thematic reviews which together would form a work plan for the remainder of 2010/11. A draft of the proposed KPI document and supporting information is presented for discussion elsewhere on this Agenda at Item 3.
- 2.3 Following further consultation with members of the Group and colleagues at BTP an updated work plan has now been developed and is presented at Appendix A of this paper. Members are asked to review and comment on the revised proposal for the meetings for the remainder of the year.
