#### **RDGP&S: Terms of Reference**

- Develop a coordinated strategic approach to the provision of security arrangements (including policing) for the rail industry (including LUL)
- Through the Rail Delivery Group, to advise the Secretary of State on governance arrangements for policing and security
- Identifying opportunities for the rail industry to deliver VfM
- Oversight of industry related security research projects
- To lead the coordinated response and reaction to the BTPA's annual consultation on the BTP's budget, Strategic Plan and National/Area Policing Plans (and any others plans to be produced in the future)
- To lead the industry consultation and strategic development of the PSA with the BTPA
- To coordinate the arrangements for rail security with DfT Land Security
- To establish a Working Group

### Developing the Focus for CP5

- Two Workshops in July
- 21 Participants
- Outcomes:
  - 39 matters for investigation (current, annual and development)
  - A strong desire to move from being reactive to proactive
  - Capability to respond to ad hoc matters (if necessary)
- These ideas have been grouped into a business plan with 5 key areas
- For each of these areas we will develop route maps showing how we plan to take forward the work
- Each route map contains a question (next slide)
- Each question is answered by going through a logical sequence of activities



#### The Focus for CP5 – Route Maps

- What is the industry strategy for policing and security of the railway?
- What are the People and Technology issues driven by the industry strategy?
- How are we going to communicate effectively what we have done, are doing and plan to do?
- How are we going to promulgate good practice and ideas about security and policing across the rail industry?
- How are we going to tackle police and security related disruption?

### **Implementation**

- Lead members allocated to each of the route maps
- Implementation Plan activities, timetable, etc.
- Assisted by an Implementation Group expanded ATOC Policing Forum to include additional Network Rail, FOC and LU representation
- Direct link to RDG through its People Workstream
- Budget in place to support development activities
- Communication Route Map will address how we communicate what we are doing and have done
