#### 6. Governance

- 6.1 In accordance with the governance rules concerning procurement the Chief Executive has approved the below single source engagements.
  - a. Punter Southall to be used to calculate the required IS19 disclosure for the statutory accounts. The single source procurement route has been used due to the charge being reduced by a third when compared with the current provider. As well as Punter Southall have indepth knowledge and understanding of all of the current active and closed pension schemes along with the experience of developing the new pension strategy for police officers.
  - b. PwC to be used to carry out an internal review of the Authority's reserves and cash flow assumptions. The single source procurement route has been used so that the Authority can appoint an organisation who have experience of work in this area and have the knowledge of the inner workings of the financial framework BTP is required to operate in.
