1. PURPOSE OF PAPER

1.1 To provide the British Transport Police Authority (BTPA) Audit & Risk Assurance Committee with an update in relation to Her Majesty's Inspectorate of Constabulary (HMIC) activity.

2. BTP INSPECTION STATUS UPDATE

- 2.1 Stop and Search
- 2.1.1 Progress is being made in relation to the implementation of the Best Use of Stop and Search Scheme. Of significant importance the following should be noted:
 - The new FIS stop and search page went live on 31st December 2014. It
 captures all the data required by the Home Office. Some minor layout
 adjustments will be made but this will not require any specific guidance for
 users.
 - In relation to the development of BTP's lay observations policy comprehensive planning and supportive documentation is required to manage the risks associated with members of the public accompanying police officers on patrol. To that end more time is being allocated to introduce this aspect of the scheme, the target date to go live for this aspect of the scheme is the end of February 2015. It should be noted that in the first instance members of the community consultation group will be asked to participate in the scheme.
 - The process in relation to 'community complaints' will be managed jointly by PSD and FHQ Territorial Policing Support. The process will make allowances



for each compliant in relation to a stop & search encounter to be scrutinised by BTP Community Consultation Group. At present the process is yet to be formalised with a standard operating procedure. It should be noted that the force receive very few complaints from encounters and once the first complaint has been received this area will be developed.

- 2.1.2 Full details in relation to progress against the Improvement Plan can be found at Appendix A. The improvement plan attached was reviewed at ICB in February 2014.
- 2.1.3 Stop & Search Revisit (Police Powers to Stop) The revisit took place in January 2015. HMIC checked progress against previous recommendations which were part of their 2012/13 national inspection programme. In addition activity was also broadened to look at the following objectives:
 - powers that the police can use to stop people, such as Section 163 of the Road Traffic Act 1988, in order to establish that they are being used effectively and fairly;
 - 2. how forces in England and Wales compare with overseas jurisdiction, both in terms of the powers available and the way they are used; and
 - Examination of the use of search powers involving the removal of more than a person's outer clothing, including strip searches, to identify whether these searches are lawful, necessary, and appropriate.
- 2.1.4 Initial feedback provided to BTP was generally positive with HMIC highlighting a number of positive messages in relation to complaints being shared with the Community Consultation Group, quarterly meetings i.e. Op Jupiter Gold Group and Stop and Search Steering Group, and the knowledge of officers (HMIC undertook a knowledge test on stop and search powers for each focus group; the lowest score was 5 out of 7). HMIC discussed a number of areas for improvement; of significant importance the following was highlighted:
 - Strip Searches clarity required around strip searches when more than outer clothing has been removed. In addition although BTP has the ability to



- identify details of every encounter via FIS, this is not widely known and the control room is not always aware
- PSD has not issued guidance in relation to complaints as to what can be disclosed at the community consultation group meetings.

2.2 <u>Inspection of Police Custody Suites</u>

- 2.2.1 The Strategic Custody Forum is operational following changes to personnel. The forum will be chaired by the Head of Offender Management on behalf of ACC B Division and Crime. The terms of reference covers progress against the remaining recommendations in the improvement plan, complaints, and service recovery to name a few.
- 2.2.2 Progress is being made in relation to introducing an internal peer review process. BTP have engaged with the City of London Police and service users In Spirit to take part. Currently issues in relation to vetting and scoping the extent of their involvement is being discussed.
- 2.2.3 Details in relation to progress against the Improvement Plan can be found at Appendix B. It is envisaged that all outstanding elements of the plan will be complete by mid March 2015. The improvement plan attached was reviewed at ICB in February 2015. The Improvement Plan has also been summitted to HMIC/P on the 16 February 2015.

2.3 Crime Data Integrity

- 2.3.1 Good progress is being made in relation to the implementation of recommendations. Of significant importance the following progress has been made against the plan:
 - Policy and procedural guidance communications have been dissemination to reiterate the process for dealing with all rape offences, which will be supervised by an officer of the rank of Detective Inspector or above. Additionally, every rape offence will be recorded as a rape on the crime system at the earliest opportunity with any cases transferred to the Home Office Force in accordance with the National Crime Transfer guidelines. This information will be included in the BTP SOP for managing seriously sexually motivated crimes, which is currently being reviewed.



- BTP has developed an internal audit action plan to address areas for improvement from the monthly internal CRIME audit findings which will be monitored via Contact Management.
- Out-of-court-disposals Offender Management will introduce Scrutiny Panels
 comprising of independent experts to review out-of-court-disposals and
 ensure options and outcomes comply with national standards. As part of the
 Offender Management Reform Project, the force will be introducing an
 Evidence Review Gateway that will have responsibility for dip sampling a
 percentage of all disposals.
- 2.3.2 Full details in relation to progress against the Improvement Plan can be found at Appendix C. The improvement plan attached was reviewed at ICB in February 2015.
- 2.3.3 It should be noted that the national recommendations from this inspection are currently being incorporated into BTP's improvement plan. At the next Home Office working group for Force Crime Registrars, progress against the national recommendations will discussed and direction provided in relation to next steps.

2.4. Core Business

- 2.4.1 BTP has contacted the College of Policing in relation to several activities that the College is leading on to request key contacts and ensure that the Force is included and aligned to the work being undertaken, however, no response has been received to date. The DCC will formally write to Chief Executive Officer of the College of Policing in relation to this matter.
- 2.4.2 Of significant importance the following progress has been made against the plan:
 - Performance Management the Performance Management Project will deliver a new performance management process and e-system with a 'go live' date of 1 April 2015. The system will allow objectives to be set at an individual and organisational level. Four blocks of objectives will be set organisationally which will ensure individual objectives are linked to BTP outcomes and priorities.



- Crime prevention strategy a national preventative policing strategy has been agreed by Op Trafalgar Steering Group, and is being implemented as part of the project. New model is a 4 Tier structure, which includes every uniform Police Officer and PCSO receiving enhanced Crime Reduction and Problem Solving training, to enable them to provide crime reduction advice and problem solve on patrol. Higher level issues will be escalated to the new Force wide Crime Reduction Department.
- Quality of Service as part of a new Skills syllabus due to be launched in April 2015, new lessons will be introduced to support the "Make the Difference" Transformation Programme. This includes new courses for both new recruits as part of their initial programme as well as experienced officers for their 'Through Life' training that covers First Fix, Stopping Crime, Offender Management and Problem Solving.
- Offender Management the process around the management of outstanding suspects who are wanted on warrant has been reviewed and has led to the introduction of a national spreadsheet which will be adopted by B and C Divisions. There will be a new risk matrix process that is aligned to the same process followed for the creation of the Integrated Offender Management. This will identify priority offenders and dictate levels of response by the Divisions.
- 2.4.3 The initial draft Improvement Plan can be found at Appendix D. The improvement plan attached was reviewed at ICB in February 2015.

2.5. <u>Undercover Policing</u>

2.5.1 Progress against the improvement plan will be monitored offline and not discussed in an open forum due to the sensitivities of tactics/operations. It should be noted that the findings from the Office of Surveillance Commissioners report has now also been incorporated into the plan and actions to be taken will be monitored accordingly.



2.6 <u>HMIC Scotland (HMICS)</u>

- 2.6.1 Stop & Search Inspection HMICS undertook this inspection in January 2015. The format of the inspection involved a number of elements including:
 - Documentation Review Stop & Search Manual of Guidance, Pocket Notebook Guidance, Performance Data
 - Fieldwork Interviews with Officers and a Focus Group in Edinburgh
 - Fieldwork Interviews with Officers and a Focus Group in Glasgow including two key interviews with C Division Lead for Stop & Search and C Division Stop & Search Champion.
- 2.6.2 Crime Recording Audit This inspection will now take place week beginning 8 March 2015. The inspection team will be reviewing data (theft, violent crime, sexual offences, non-crime related incidents, no crimes) from April 2014 September 2014.

3. MISCELLANEOUS REPORTS PUBLISHED BY HMIC

3.1 Audit & Compliance monitor all national reports published by HMIC. Where BTP have not been involved in the relevant area of inspection these reports are disseminated to appropriate departments internally in order to ascertain BTP's current position, risk implications, and impact. Action Plans are put in place locally with recommendations reviewed and monitored at Force level via ICB and/or submitted to BTPA Audit & Risk Assurance Committee for informational purposes. It should be noted that since the last Committee meeting there has been one relevant policing report published by HMIC that require action by BTP as noted in the below table.
