7. Stakeholder Engagements

The Chairman and Chief Constable hosted a very 7.1 successful pilot stakeholder dinner in Manchester on 20 September. The event was attended by managing directors from a number of TOCs operating in the North West, Transport Focus, Network Rail and Transport for the North. Topics discussed included Scottish devolution. police reform, counter terrorism and operational assumptions for the development of the policing plan for 2017/18. The event identified a number of options for collaboration and partnership working around training and CCTV amongst other issues. Attendees supported the new approach and welcomed the opportunity to discuss strategic issues from a local perspective; the Executive team is now arranging follow up events to be held in Scotland, Wales, Birmingham and London before the end of the financial year.
