- 4.1 The Chair recently met Phil Verster Abellio Scotrail on the 31 May in Glasgow. The arranged visit with Caledonia Sleeper was postponed at Peter Strachan's request as he was out of the country on the scheduled date of the 1 June 2016.
- 4.2 The next round of stakeholder visits is currently in the process of being arranged for later in the year

# 7. PSAs / Contracts

- 7.1 Following a meeting with DB Cargo concerning their PSA charges a resolution will be presented to the Finance Committee for approval.
- 7.2 In relation to South West Trains, meetings have been held and a resolution is being out together for submission to the Finance Committee to review and approve.

## 8. Pensions – Transferees

8.1 Since the last meeting there have been no requests for Home Office Transferees into the 2007 scheme. The Pensions working group have approved the transfer of an officer from the 2007 scheme into the CARE scheme.

#### 9. Finance Review Report

9.1 With the completion of the focus on the year-end the attention of the Finance Action Plan sessions has been shifted back to the original plan submitted to the DfT. The goals and actions have been added to where new issues have been identified. These have been redistributed into three headings of short, medium and long term to ensure sufficient focus is given to both issues requiring immediate attention as well as those long term actions which require more consideration and discussion. A Finance Action Plan meeting to review the updated plan in detail is to be held after the Authority meeting on 16 June 2016.

10.1 A verbal update will be provided during the meeting following the recent meetings that have taken place.

#### **11.** Policing Plan

11.1 The Authority has received a request from ACC Newton to make an amendment to two local targets on B-Division, one each on East and South sub-divisions. This would be a wording change to remove '10%' from two local targets to reduce physical violence on East and South; making them simple rather than quantified reduction targets. The rationale is set out in some detail in the attached paper at Appendix B.

- 11.2 If supported the change would:
  - a) Be consistent with the wording we used to consult stakeholders in January, the 10% figure was added by BTP post consultation
  - b) Create consistency in approach across all divisions
  - c) Address concerns expressed by the Chief Constable at the recent away-day about the intended consequences of the application of some numeric targets, ACC Newton believes that retaining a 10% target may encourage a focus on lower level but higher frequency crime rather than those crimes which cause greatest risk of harm.
  - 11.3 The Policing Plan Group would recommend the proposed change to the Authority for approval.
